

FY '05 President's Budget Request

- \$28.757 billion
 - ~ 2.6% increase over FY 2004
- Approximately 10,400 competing RPG awards
 - ~ 260 increase over FY 2004
- Major initiatives
 - Obesity
 - Biodefense
 - AIDS
 - NIH Roadmap

Sharing resources (model organisms)

- **PIs:**
 - Must include in application specific plan for sharing & distributing unique model organism research resources generated using NIH funding **OR**
 - State appropriate reason why sharing is restricted or not possible
- **Reviewers:**
 - Will review plan
 - May comment in administrative note
- **IC staff:**
 - Will take into consideration for future funding decisions failure to comply w/ NIH resource sharing policies, guidelines, and the accepted plan
- **Effective date: October 1 2004 receipt date**

Sharing data: implementation of policy


- **PI's:**
 - Must include plan for sharing of final research data if application requests \$500K or more direct costs in any single budget period
OR
 - State why sharing data is not possible
 - May request funds for sharing and archiving
- **Reviewers:**
 - Will NOT assess data sharing plan in determining scientific merit or priority score
 - May assess data sharing plan if so specified in RFA or RFP
- **IC staff:**
 - Will assess the appropriateness and adequacy of data sharing plan
 - Must resolve concerns prior to making an award
- **Effective for applications received on or after October 1, 2003**

Consortium costs – change in direct cost limitations on solicited applications

- Applications received in response to PAs or RFAs may exclude from the direct cost limit the F&A costs requested by consortium participants
- NIH policy on acceptance of applications requesting direct costs of more than \$500K in any one year still applies

Salary Cap

- Restricts the amount of **direct salary** under a grant or contract to Executive Level I of the Federal Executive Pay Scale
- Executive Level I increase effective January 1, 2004

National Science Advisory Board for Biosecurity (NSABB)

- To advise Federal departments and agencies on ways to minimize the possibility that knowledge and technologies coming from biological research will be misused to threaten public health or national security
- Charged to guide development of:
 - A system of research review that allows for fulfillment of research objectives while addressing national security concerns
 - Guidelines for identification and conduct of research that may require special attention and security surveillance
 - Professional codes of conduct for scientists and laboratory workers
 - Materials and resources to educate the research community about effective biosecurity

Research Business Models (RBM)

Subcommittee

- A subcommittee of the Committee on Science (a chartered committee of the National Science and Technology Council)
- Charge:
 - Facilitate coordination across Federal agencies to address important policy implications arising from changing nature of scientific research
 - Examine effects of these changes on business models for the conduct of scientific research sponsored by Federal government
- Working groups of RBM subcommittee to address:
 - Alignment of funding mechanisms w/ scientific opportunities
 - Common practices across agencies
 - Stewardship and accountability

Facilitating Collaborative Multidisciplinary Research

- Acknowledgement of Co-PIs in proposals and agency information systems
- Stability and predictability of support for research facilities and instrumentation independent of individual projects
- Support for graduate and postdoctoral students with regard to salary, stipends, tuition, benefits, etc.
- Collaboration between universities, federal laboratories, and industry

Improving Consistency of Agency Practice

- Standard progress and financial reporting procedures.
- Broader use of the Federal Demonstration Partnership (FDP) model sub-agreement templates
- Consistent award notices format and terms and conditions

Harmonizing Accountability

- A-133 monitoring requirements for A-133 compliant institutions
- Consistent Federal-wide policies for Research Misconduct
- Consistent Federal-wide policies for Research Conflict of Interest

Future Plans for eRA (1)

- New Query/Reporting Tool (Est. Fall '04)
- Organizational Hierarchy—ability for institutions to customize access to data based on organizational structure
- Continued improvements to existing functionality

Future plans for eRA (2)

- Electronic grants submission
 - February 2005 – electronic submission of modular R01 grant applications
 - Download, complete and submit via Grants.gov
 - Work w/ an SBIR service provider
 - Become your own service provider by enabling your own system to interface with the NIH Competing Grants Process interface
